



## Parent/Guardian Agreement

**Parent/Guardian Authorization (or self if 18)** – In order to participate in Teens Like Me (TLM) projects and activities, youth volunteers must have your written permission.

**Parent's Responsibility** – I will take responsibility to see that my child/ward (or self if 18) is properly prepared for all Teens Like Me activities including having the proper clothes and equipment, and being in good health, and will inform the Internship Advisor of any particular physical, mental, social, or other condition of my child/ward (or self if 18) of which the Internship Advisor should be aware.

**Medical Care Authorization** – I understand that reasonable measures will be taken to safeguard the health and safety of all participants and that I will be notified as soon as possible in case of an emergency affecting my child/ward (or self if 18), or if my child/ward (or self if 18) is not feeling well or is unable to function.

I understand the fact that service work, involve risks. These risks include but are not limited to: possibly dangerous work conditions beyond the control of TLM's; I understand the nature of this program and its activities and voluntarily accept these risks, and waive claims I may now and in the future have against TLM's from all liability and covenant.

**Student Conduct** - Students may not use, pursue use of or possess tobacco products, alcohol, illegal drugs/substances.

Abusive, violent, unsafe behavior, theft, vandalism, chronic defiance of program policies and established rules or profanity or other pervasive negativity will not be tolerated. Violation of these guidelines will result in dismissal at the sole discretion of TLM.

Students who are dismissed from the program for any of the aforementioned reasons will not receive community service credits. Directions and policies set forth by staff for the safety, health and well being of all participants, and of our host community, will be followed at all times.

I give permission to TLM's to use my child's picture and images derived from his/her activities during the program, and I agree that any photographs/videotapes taken by TLM's that include the participant, and/or statements by the participant, may be used in promoting Teens Like Me, Inc.

I have read and agree with the **Noteworthy Information** and Terms of Participation contained therein. I agree to release TLM's, its agents and adventure services of any and all liability, waiver of all possible claims, and responsibility for any loss/damage to property or personal injury incurred during the program under the direction of TLM's, in which my son/daughter/ward is participating.

[Notwithstanding, jurisdiction for legal action will be in Fulton County, Georgia in accordance with the laws of Georgia.]
